## **INTRODUCTION**

## RULES OF RESERVATION SERVICES OF THE COMPANY

## 1) Make a reservation

The company accepts reservations each day, including public holidays – 24 hours per day.

The procedure for booking is as follows:

- Step 2: User enters the number of people, date and time of booking.
